DEACON REPORT

Lisa updated Session on the upcoming Grief Share Ministry. They are starting with a two-session program on Surviving the Holidays. They will offer an afternoon and evening session on 11/18 and 12/16. A donation was received to pay for the materials. Roseann Tebo memorial service is 11/15. A holiday gift will be delivered to those on the Deacon's TLC list on 11/23 this year because it is an advent calendar. The Deacons are hosting the joint Session/Deacon meeting on 12/2 at 6:00 PM. Discussed reworking the Connect Table to better integrate it into after service socializing.

COMMITTEES:

Building & Grounds

Greg presented three bids for an HVAC system for the CAC. Discussed available funding for the project and the donation we received as a matching donation for the project. Discussed the bid

to complete the woodwork project in the CAC. Also discussed bids received for completing the recording studio with the remaining budgeted funds for that project.

MSC Authorized the completion of the woodwork in the CAC by Nathan Benner as bid and installing a new HVAC in CAC by accepting the bid from Welkin Heating & Air.

Cory will update the congregation and announce the donation we received to match donations from the congregation for the CAC HVAC project up to \$10,000.

Bid to steam clean the pews was discussed and decided to wait until after the candle-light Christmas eve service to do this since there are many wax stains to remove in the cleaning.

Finance

Bob presented the 2026 budget as proposed by our Staff. We will wait until we know more about our 2025 giving totals to approve the proposed budget. Discussed leasing the Wilson Center. We will proceed on a dual path. We will complete due diligence on the current lease proposal while we continue to pray over the concept of leasing the Wilson Center. We will do a pray walk of the Wilson Center on Tuesday, 11/4.

MSC Authorize our leasing agent to present a counteroffer to the current lease proposal.

Finance committee will continue to complete due diligence and vetting of the lessee, including talking with their current lessor, Servants Church.

PASTORS REPORT

Pastor Banning has been working with the staff on their roles and needs and with Personnel Committee to adjust the current job descriptions and to add additional part-time positions.

Youth Director Role- Pastor Banning has identified someone to take on this role part-time to help Kaedin. This role and job description will continue to be refined.

MSC Authorize a part-time temporary position of Youth Director with a stipend of \$150/week through the remainder of the 2025.

Preschool Coordinator Role – Pastor Banning has identified with Beth Ann that help is needed to establish the Sunday preschool program. He has also identified someone he would like to fill that part-time position.

MSC Authorize a part-time Childrens Ministry position of Preschool Coordinator with a stipend of \$200/week.

For 2026 Pastor Banning has been working on a “Who we are” campaign where every ministry will be asked to define their vision, goals, and needs. He provided Session with some materials to study as a background for the project.

He announced that Elder Kirk Sandvig has agreed to be the Elder over Christian Education.

Moved into executive session and dismissed Pastor Greg.
